BELOW ARE A FEW ITEMS THAT A NEW OR EXPERIENCED EXHIBITOR NEEDS TO MAKE SURE TO TAKE CARE OF:

_____ EARNED 20 POINTS WORKING THE FOOTBALL CONCESSION STAND (IN AUGUST OR SEPTEMBER) OR SELL EXTRA FRUIT, MEAT AND COOKIE DOUGH TO MAKE UP FOR LACK OF TIME IN CONCESSION STAND.

_____ SOLD AT LEAST 25 ITEMS (FRUIT, MEAT, COOKIE DOUGH) 35 IF YOU HAVE SIBLINGS IN FFA OR JR. FFA THAT ALSO SHOW — IF YOU DID NOT MEET THIS REQUIREMENT, YOU CAN PAY \$5.00 PER ITEM YOU

_____ ATTENDED MEETINGS (2ND MONDAY OF EACH MONTH) — INFORMATION IS ANNOUNCED AND A WAY TO EARN POINTS.

_____ ORDERED AN FFA JACKET FOR THE SJLS AUCTION. I KNOW I WILL ALSO NEED BLACK JEANS AND A WHITE BUTTON DOWN SHIRT.

_____ EARN 150 POINTS IF I AM AN FFA MEMBER OR 100 POINTS IF I AM A JR. FFA MEMBER TO BE ELIGIBLE TO SHOW AT THE SCHULENBURG JR. LIVESTOCK SHOW.

_____ ENSURE MY ANIMAL IS AT THE CORRECT TAG IN DAY OR THAT I PLACED MY BROILER ORDER BY THE DEADLINE.

- SHEEP TAG IN DATE: OCTOBER 7, 2024 (4:00 PM — 6:00 PM — PLACE: TBA)
- RABBIT VALIDATION: WEDNESDAY OF THE LAST WEEK OF THE FALL SEMESTER FOR SISD. (BY APPOINTMENT)
